



MEMBERSHIPS

The following are fees and charges, rights and privileges for November 1, 2008 to October 31, 2009 and all are subject to change.



MEMBERSHIP PRIVILEGES AND REQUIREMENTS

ALL MEMBERSHIPS:

- Must abide by Club By-Laws and General Club Rules.
- Cart fees are for 9 or 18 holes per day. If wishing to pay additional holes another cart fee will be applied.
- All memberships that have golfing or tennis privileges may call 5-days in advance for Tee or Court time.
- Have charge privileges and will be issued a charge number.
- Golf lockers are included for all memberships that have golfing privileges.
- Tennis lockers are included for all memberships with tennis privileges.
- Only members owning property in Panther Woods and having a garage for storage for a cart may have a private cart.
- Only active Equity Members may vote on Club matters.
- Dues and food and beverage, for equity and annual memberships, will be pro-rated the first year of joining.
- Applications for Membership must be approved by Board of Governors.
- All dues, food and beverage subject to 6.5% tax. No tax on Equity fees.

GOLF

- Equity and Non-Equity Memberships available. Equity Members required to pay Equity Fee.
- May use the golf, tennis, pool and dining facilities and join in all social activities.
- No court or green fees. Cart, trail or annual cart fees apply.
- May join LGA or MGA upon payment of dues and are eligible for all Club Tournaments.
- Food & Beverage: if you pay single dues but have a spouse or dependant children living at home, you will be charged family food & beverage.
- May live inside or outside Panther Woods community.

SPORTS

- Equity and Non-Equity Memberships available. Equity Members required to pay Equity Fee.
- May use the golf, tennis, pool and dining facilities and join in all social activities.
- Cart, trail or annual cart fees apply plus green fees at 75% of Member Guest Green fee.
- May join LGA or MGA upon payment of dues and are eligible for all Club Tournaments.
- Food & Beverage: if you pay single dues but have a spouse or dependant children living at home, you will be charged family food & beverage.
- May live inside or outside Panther Woods community.

TENNIS/SOCIAL

- Equity and Non-Equity Membership available. Equity Members required to pay Equity Fee.
- May use the tennis, pool and dining facilities and join in all social activities.
- No court fees.
- May play golf five times during the Winter period of 1st November to 30th April and anytime during the Summer Season, May 1st to October 31st at the Member Guest Green Fee rate plus cart fee.
- Food & Beverage: if you pay single dues but have a spouse or dependant children living at home, you will be charged family food & beverage.
- May live inside or outside Panther Woods community.



MEMBERSHIP PRIVILEGES AND REQUIREMENTS

SIMPLY TENNIS

- Non-Equity membership.
- Unlimited tennis, no court fees.
- No F&B minimum.
- Dining privileges only but may be a guest at the following social functions: themed Wed. night dinners from Nov 1 to Apr 30, Halloween Dinner Dance, Welcome Back Dinner Dance, New Year's Eve Dinner Dance, Wine Club, Valentines Dinner Dance, St Patty's Day Dinner Dance, Margarita Ville or Summer Kickoff Dine & Dance

ASSOCIATE MEMBERSHIP

- Must be 50 years or under on Nov 1
- Non-Equity Membership.
- Includes golf (as specified below), tennis, pool, dining and all social activities.
- Golf has certain restrictions:
 - Winter season, Nov 1 to Apr 30: may play after 12 noon on weekdays and anytime on weekends and public holidays
 - Summer Season, May 1 to Oct 31 - May play at any time.
 - No green fees if playing during restricted times. Cart, trail or annual cart fees apply. If playing other than restricted times, must pay same green fee of Sports Member.
 - May play in all golf tournaments.
- Not open to current or resigned Equity Members.
- May live inside or outside Panther Woods community.

LEISURE TIME MEMBERSHIP

- Non-Equity Membership.
- Includes golf (as specified below), tennis, pool, dining and all social activities.
- Golf has certain restrictions:
 - Winter season, Nov 1 to Apr 30: may play after 12 noon
 - Summer Season, May 1 to Oct 31 - May play at any time.
 - No green fees if playing during restricted times. Cart, trail or annual cart fees apply. If playing other than restricted times, must pay full green fee.
 - May not play in Club golf tournaments.
- Not open to current or resigned Equity Members.
- May live inside or outside Panther Woods community.

SNOW BIRD

- Non-Equity Membership.
- Includes golf (as outlined below), tennis, pool, dining and all social activities.
- Golf
 - Unlimited golf. No green fees but cart or annual cart fees apply.
 - May join the LGA & MGA upon payment of fees.
 - Certain restrictions re play in tournaments. Refer to "Golf Tournament Eligibility" sheet.
- Not available to: Panther Woods property owners; to current or resigned Equity Members; or to Florida residents.
- People leasing from PW residents, who do not have a membership, may purchase this membership.
- Membership is non-transferable.



MEMBERSHIP PRIVILEGES AND REQUIREMENTS

PW RESIDENT DINING

- Dining privileges (same as Simply Tennis above)
- Open to residents of Panther Woods except those with a resigned membership.

CORPORATE MEMBERSHIP

May be tailored to specific needs. Make inquiries to the General Manager.

LIFETIME MEMBERSHIP

The upfront payment, giving you a lifetime of no greens fees or F&B, will be customized depending on your age at time of application.

SUMMER MEMBERSHIPS FOR 2009

ALL SUMMER MEMBERSHIPS:

- Non-Equity Membership for up to six months between the 1st May to 31st October 2009
- May live inside or outside Panther Woods community.
- Not available to resigned Equity Members.
- People leasing from PW residents, who do not have a membership, may purchase this membership.
- Membership is non-transferable.

GOLF

- Includes golf (as outlined below), tennis, pool, dining and all social activities.
- Golf
 - Unlimited golf. No green fees but cart fees apply.
 - Certain restrictions re play in tournaments. Refer to “Golf Tournament Eligibility” sheet.
- No F&B minimum.

TENNIS

- Includes unlimited tennis (no court fees), pool, dining and all social activities.
- No F&B minimum.

DINING

- Includes dining and social privileges only.
